# CGMA Finance Leadership Program™

'Pathway to the CGMA designation'

### Introduction

The \*CGMA Finance Leadership Program™ (FLP) offered through University of Johannesburg online short learning programmes (SLPs) aims to assist students to complete their \*\*CIMA qualifications in a structured and cost-effective manner.

Given the fast-evolving skills and competencies required for engaged professionals to remain relevant and at the cutting edge of skills and competencies required in the world of work, to be considered for career progression and salary advancement, lifelong learning (LL) is an imperative. The FLP allows this segment to consider ways in which to access an education that provides LL and its related benefits; and, given the FLP learning journey, to learn just-in-time (JiT), to become highly skilled and competent in current work-related tasks.

To acquire the CIMA qualification, students need a total of 16 CIMA credits across 4 CIMA levels.

The CIMA SLPs will complement the formal CIMA accredited tertiary qualifications by assisting students to complete the professional qualification and obtain the ACMA, CGMA designation.

## How will you learn?

The CIMA SLPs will be delivered online on the CGMA Learning Management System, and the students will be supported by UJ qualified lecturers.

Once students register for the SLPs, they will receive a link directly from CIMA with further instructions to complete the FLP registration which will give them 1-year access to the CIMA FLP™. The students will receive the following benefits from registering:

- Student Registration fee
- Student Annual student fee
- Competency area learning & Business simulations
- Elimination of OTQ exams and exam fees and textbooks

- Case Study Review and Exam resources including pre-seen analysis and graded mock exam
- One Case Study Exams Credits (per required exam)
- Ability to earn awards (i.e. Skills Certificates, CIMA Diplomas and CGMA/ CIMA qualification)
- Ongoing support from UJ lecturers

### Admission

#### CIMA Strategic Level FLP™

This Short learning programme is suitable for students with the following minimum NQF Level 8 qualifications:

- BCom Honours (Financial Management) or
- Postgraduate Diploma in Financial Management (PGDFM) AND
- Management Case study\* or CIMA Adv Dip MA (12+ CIMA exemptions)
- \* Students who have not written the Management Case Study after their qualification will be accepted but will be liable for additional fees for the Strategic Case study.

#### CIMA Management Level FLP™

This Short learning programme is suitable for students with the following minimum NQF Level 7 qualifications:

- Advanced Diploma in Financial Management (ADFM),
- Bridging Programme in Financial Management OR
- BCom (Accounting) (8 CIMA exemptions) OR
- CIMA Diploma in Management Accounting (CIMA Dip MA)

### CIMA Operational Level FLP™

This Short learning programme is suitable for students with the following minimum NQF Level 6 qualifications:

- Diploma in Accounting (4 CIMA exemptions) OR
- CIMA Certificate in Business Accounting (Cert BA) exemptions.

## Documents required

**NB**: Qualifications that are 7 years and older will impact your exemptions and we urge students to email CIMA (Exemptions.Africa@aicpa-cima.com) to inquire about the correct level of entry if their qualifications are 7 years and older.

Please ensure that you attach ALL the supporting documents with your application to avoid unnecessary delays with your application.

The following documents:

Certified copy of ID document

- Certified copy of Marriage Certificate (If applicable e.g. your Surname is different on your Grade 12 Certificate to what appears on your Tertiary Qualification Certificate/s)
- Certified copy of Matric / Senior Certificate / School Leaving Certificate
- Certified copy of Tertiary Qualification and/or CIMA Certificate/s and CIMA Exemptions
- Certified copy of Academic Record of your qualification/s obtained

When scanning, all documents must be scanned as separate attachments viz. NSC results separate, academic record and degree or diploma certificate etc.

The scanned format to be used must be JPEG, GIF or TIFF files, which is much more user-friendly for our document management system.

## **Applications**

There will be three intakes annually to coincide with the four CIMA Case study sittings and the closing date for each intake is 5-days before the course commences.

- First intake January: May Case study sitting
- Second intake April: August Case study sitting
- Third intake August: November Case study sitting

### Course outline

Each SLP will be run for approximately 5months which will cover the competencies (E, P & F Pillars) for each level and prepare students for the Case study exam.

#### CIMA Strategic Level FLP™

The purpose of the CIMA Strategic Level FLP™ is to provide students with the necessary financial and risk management knowledge and skills to support long-term strategic decision making. Upon completion of the SLP students should be prepared to sit the CIMA Strategic level Case study exam. The programme will focus on the following broad topics:

- Financial Objectives
- Risk oversight
- Internal Controls
- Strategy formulation and execution
- Regulatory Compliance

#### CIMA Management Level FLP™

The purpose of the CIMA Management Level FLP™ is to provide students with the necessary skills of translating long-term decisions into medium-term plans and builds on topics covered at the Operational level. Upon completion of the SLP students should be prepared to sit the CIMA Management Level Case study exam. The programme will focus on the following broad topics:

- Cost Management
- Financial Statement Analysis
- Leadership and Management
- Business Models
- Organisational Performance

#### CIMA Operational Level FLP™

The purpose of the CIMA Operational Level FLP™ is to provide students with the necessary short-term decision-making skills and build on a student's core knowledge of finance, accounting and reporting. Upon completion of the SLP students should be prepared to sit the CIMA Operational Level Case study exam. The programme will focus on the following broad topics:

- Data Analytics
- Budgeting
- Regulatory Framework
- Cost Accounting
- Finance Technologies
