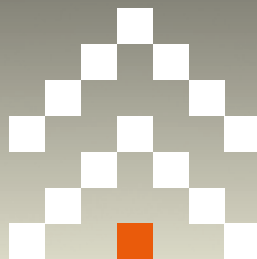

Programme Overview

This course provides a general outline of the South African legal system as it is dealt with in the Paralegal Programme. There is a section on legal language in this Bridging Programme which will cover the application of English language as a medium of communication in the South African legal system. The purpose of this course is to not only grant you access to the Diploma in Paralegal Studies but to prepare you for the Paralegal Programme, and to also provide insight into the broader legal system.

Assessments

A written Assignment is provided during the course attendance where candidates are expected to obtain at least 50% in the Assignment in order to progress to the first year of studies of the Diploma in Paralegal Studies within the same year.

Lectures and Workshops

Lectures are presented in-person over four days.

Prescribed Material

The programme fee includes all prescribed study material.

Admission Requirements

National Senior Certificate endorsed for Certificate or Higher Certificate studies.

Application Dates

Applications open from **31 August 2024** to **20 February 2025**. Late applications may be accepted.

Documentation Required

- A certified copy of the Senior Certificate/Matric Certificate (Grade 12) or equivalent qualification;
- Certified marriage certificate (if applicable);
- Certified copy of Identity document,
- HESA evaluation of qualifications (**only for international applicants**)

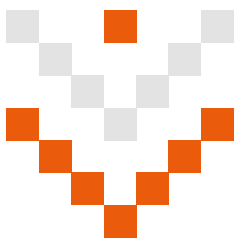
Please note: The fee or any part thereof is not refunded or carried over to another year in respect of students who are, for any reason, not able to complete the duration of study.
