Tankiso is a professor of accounting whose research interest focuses on digital transformation, artificial intelligence, financial and non-financial reporting, and risk management. He has published numerous papers. He has further written and edited numerous books with leading publishers such as Springer, Palgrave, De Gruyter, LexisNexis, and JUTA. In his 10 years in the higher education sector, he has supervised 16 Ph.D's to completion, 18 master's dissertations/ projects to completion, and 84 honors research projects to completion. Tankiso has assessed more than 80 doctoral and master theses from other universities. He has also secured over ZAR22m in research and skills development grants which is a testimony to the relevance and impact of his work.

In his career, Tankiso has held various positions in the finance, mining, and higher education sectors. Currently, he holds the role of Executive Dean of the College of Business and Economics at the University of Johannesburg. His previous roles include Academic Director, Chair in 4IR, Director of Enterprise Risk Management, Chief Accountant, as well being Chief Economist, Senior Economist, and Economist (responsible for Financial Statistics).
